Introduction to the NRF

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act. The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities. The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. All contracts flowing from bidding only apply to iThemba LABS (Cape Town).

Introduction to the Business Unit responsible for this RFQ

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and applied nuclear physics research using particle beams
- Research Radiation Biophysics
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research

Evaluation Process

- Evaluation of proposals:

All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to successful bidder.
- Preference points system:

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. If all bidders received are more than R500k, the proposal will be cancelled and re-issued.

DETAILS SPECIFICATION:

1. Introduction and Background

The iThemba Laboratory for Accelerator Based Sciences (iThemba LABS or iTL), a facility governed by the National Research Foundation (NRF) based in Cape Town has embarked on an alternative water supply project. The project intends to use groundwater from the underlying aquifer for industrial and domestic purposes.

At present iTL uses an average of 120 kl/day from the municipality both for domestic and industrial. The aquifer is expected to deliver this volume of water on a daily basis. The geo-hydrological assessment study is to be conducted to confirm the sustainability of the aquifer to provide the required water quantity.

Based on the groundwater quality investigation, it was revealed that the water quality is not fit for the intended uses. For this reason, a water treatment plant (Reverse Osmosis) was recommended to purify groundwater so as to meet the SANS 241:2015 standards.

The Reverse Osmosis (RO) plant is expected to have an efficiency of 75 – 85 % from which 25 -15 % may form brine effluent. The disposal of effluent brine might detrimentally impact the receiving environment. To avoid environmental contamination, an existing evaporation pond/dam onsite is recommended to store brine effluent.

iTL seeks the services of an Environmental Assessment Practitioner (EAP) to undertake an Environmental Impact Assessment (EIA) of brine effluent from a Reverse Osmosis plant.

2. The Environmental Impact Assessment Scope

Conduct an environmental assessment which includes the following:

- The biophysical status of the Site and areas in the close proximity as required by legislation.
- Risk assessment of operations at iTL that relate to brine effluent.
- Identification and description of sensitive areas that might be impacted by brine effluent on-site.
- The impact of brine effluent into the geo-hydrological environment since brine may impact groundwater quality on-site and the surrounding areas.
 - NOTE: A detailed geo-hydrological report would be made accessible and should be considered when compiling the EIA report.
- Describe the nature of brine effluent

- Provide recommendations as to how brine from the iTL operation could be stored and disposed of.
- Identify and explain the legislative requirements and permits/licenses required to dispose brine for the various recommended options.

In summary, this study is the first phase of the project from which the primary intention is to determine the best method to handle and dispose brine effluent from the RO plant and to advise on what permits and licences are required to do so.

The second phase would involve the application process to the relevant authority for permits/licences required for the selected option of brine disposal and storage.

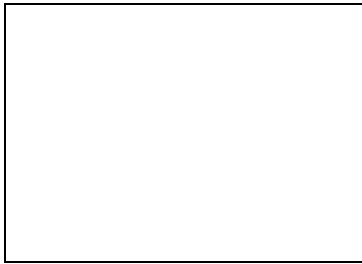
