SCHEDULE 1 - SPECIFICATION

Introduction to the NRF

The National Research Foundation ("NRF") is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act. The NRF is the government's national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities. The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. All contracts flowing from bidding only apply to iThemba LABS (Gauteng).

Introduction to the Business Unit responsible for this RFQ

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and applied nuclear physics research using particle beams
- Research Radiation Biophysics
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research

Evaluation Process

- Evaluation of proposals:

All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to successful bidder.

- Preference points system:

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. If all bidders received are more than R500k, the proposal will be cancelled and re-issued.

DETAILS SPECIFICATION:

iThemba LABS requires the services of a Certified Service Provider with proven competence and experience to Remove and Dispose of identified Hazardous Chemical Waste at iThemba LABS: Gauteng. The service provider must ensure that all work performed and/or equipment used on site complies with all the applicable regulations.

DESCRIPTION OF WORKS

- ❖ The inventory to be disposed is as follows:
 - 1000 litres of chemical waste solution with Hydroflouric, Nitric, Hydrochloric, and Acetic acids, (filled to the brim ~1200 litres)
 - 800 litres of chemical waste solution of Hydroflouric, Nitric, Hydrochloric, and Acetic Acids, (not full yet)
 - 25 l carboy containers with Hydroflouric, and Nitric, Acetic Acids with Eucalyptus oil,
 - 2 dustbin packets with gloves, wipes, aluminium foils used to wipe and contain Beryllium Oxide (also known as carborogen).
- ❖ Provide a comprehensive process flow indicating how waste will be analysed, identified, packaged/drummed, transported and finally disposed of at an approved waste disposal facility.
- ❖ Provide transportation of the waste from the iThemba LABS facility to the disposal site via the use of your own vehicles. The vehicles will be properly maintained and mechanically sound and be fitted with the required regulated signage, serviced fire extinguishers, Hazchem spill kits and have tracking systems.
- ❖ Vehicles will be operated by properly trained personnel employed by the service provider. These personnel will be required to:
 - ✓ Wear proper personal protective equipment and/or clothing
 - ✓ Be knowledgeable in the handling of hazardous chemical substances
 - ✓ Be knowledgeable in the use of fire extinguishers and Hazchem spill kits and how to contain a spill.
 - ✓ Access to a First-Aid kit and knowledge on First-Aid training will be an added advantage.
 - ✓ Drivers will never operate a vehicle alone and should always be accompanied by at least one additional team member.

- ❖ Have access to certified laboratory services for the analyses of hazardous chemical substances which will assist in determining the proper disposal method for the identified chemical group type.
- ❖ Drums will be labelled in accordance with applicable regulations and be handled in such a manner so as to prevent spillages or dangerous release of its contents. This should be done through the use of safety equipment such as lift trolleys or other similar equipment.
- ❖ Provide Waste Manifest Documentation (with a document tracking number), a landfill generated weigh bridge certificate and a safe disposal certificate which will accompany all invoices.

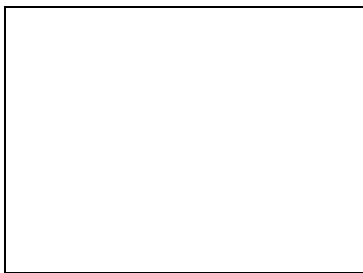
