## **Introduction to the NRF**

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act. The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities. The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. All contracts flowing from bidding only apply to iThemba LABS (Cape Town).

## **DETAILED SPECIFICATIONS**

### **1. Removals**

Remove existing aluminium doors in ground floor reception area from the inside entrance as well as the doors leading to the offices and lift. The tag lock system on the entrance door should be kept for reinstallation and the remaining frame and glass should not be damaged.

### **2. Installation**

#### **2.1. Entrance door**

The sliding doors for the entrance shall be of automatically operated, vertical bi-parting type. The doors shall be brushed flat finished aluminium structured frame construction, designed so that the clear door opening shall be equal to the full width 1.5m of the opening and in line with the height 2.5m of the opening to give unobstructed access when open. The door shall have an electronic tag lock that will open the doors after hours with an override button on the inside, this tag lock shall be the same one that was previously removed. While in usual working hours the door will operate normally as an automated door. An auto/manual button should also be implemented to keep door open when required.

The doors shall be of rigid and robust construction, suitable to withstand the impact of goods being handled and the general abuse usually occurring in service areas.

The doors shall be supported at the bottom by bearing tyred runners in smooth polished aluminium track and guided at the top by non-metallic shoes sliding in smooth machined grooves. The doors shall completely close off the door opening, lock positively and be equipped with the necessary safety devices to prevent the mechanism from sliding unless otherwise allowed.

#### **2.2. Door to offices**

The sliding doors shall be of automatically operated, vertical bi-parting type. The doors shall be brushed flat finished aluminium structured frame construction, designed so that the clear door opening shall be equal to the full width 1.5m of the opening and in line with the height 2.5m of the opening to give unobstructed access when open.

The doors shall be of rigid and robust construction, suitable to withstand the impact of goods being handled and the general abuse usually occurring in service areas.

The doors shall be supported at the bottom by bearing tyred runners in smooth polished aluminium track and guided at the top by non-metallic shoes sliding in smooth machined grooves. The doors shall completely close off the door opening, lock positively and be equipped with the necessary safety devices to prevent the mechanism from sliding unless otherwise allowed.

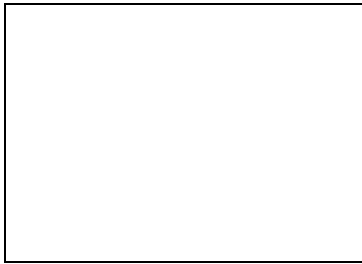
