# **SCHEDULE 1 - SPECIFICATION**

## **Introduction to the NRF**

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act. The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities. The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. All contracts flowing from bidding only apply to iThemba LABS (Cape Town).

## **DETAILED SPECIFICATIONS OF GOODS AND SERVICES:**

### **Installation of one (1) diameter 150mm gate valve and tee with 150mm swing check valve**

The area for the installation of the new valve and swing check valve will be installed at point no.1 as indicated on the layout below. The area at which the 150mm gate valve, tee and swing valve will be installed must be excavated with sufficient clearance to install the new equipment.

The existing asbestos pipe must be carefully cut to tie in the new gate valve, tee and swing valve.

The supply and installation of a new diameter 150mm RSGV DN150OD177 Plain AVK Resilient Seal gate valve with an AVK Resilient Seal Swing check valve series 41-150-61-018 with connections from the gate valve to check valve and Klamflex ranger couplings to suit or similar/equivalent to. All seals, gaskets, nuts bolts and other fixings must be included.

Upon completion of the installation a concrete base must be cast. Supply and install a HDPE inspection manhole with cover.

### **Replacement of two (2) diameter 100mm gate valves**

The isolation valves to main water distribution feed to the water reservoir has to be replaced as they no longer shut completely at points 2 &3 on layout below. The valves are situated in manholes (1m x 1m x 1.5m) next to the water reservoir. The size of the outside diameter of the asbestos 100mm. The exiting valves and ranger couplings must be removed and replaced with RSGV DN100OD122 plain AVK Resilient Seal gate valves and Klamflex ranger couplings to suit or similar/equivalent to.

All seals, gaskets, nuts bolts and other fixings must be included.

### **Installation of one (1) diameter 150mm gate valve with 150mm water meter**

The area for the installation of the new valve and swing check valve will be installed at point no.5 & 6 as indicated on the layout below. The area at which the 150mm gate valve and 150mm Sensus Meistream Plus water meter which must be epoxy coated.

The areas at which the valve and meter will be installed must be excavated with sufficient clearance to install the new equipment.

The existing asbestos pipe must be carefully cut to install in the new gate valve and water meter.

The supply and installation of a new diameter 150mm RSGV DN150OD177 Plain AVK Resilient Seal gate valve and Klamflex ranger couplings to suit or similar/equivalent to.

All seals, gaskets, nuts bolts and other fixings must be included.

Upon completion of the installation a concrete base must be cast. Supply and install a HDPE inspection manhole with cover.

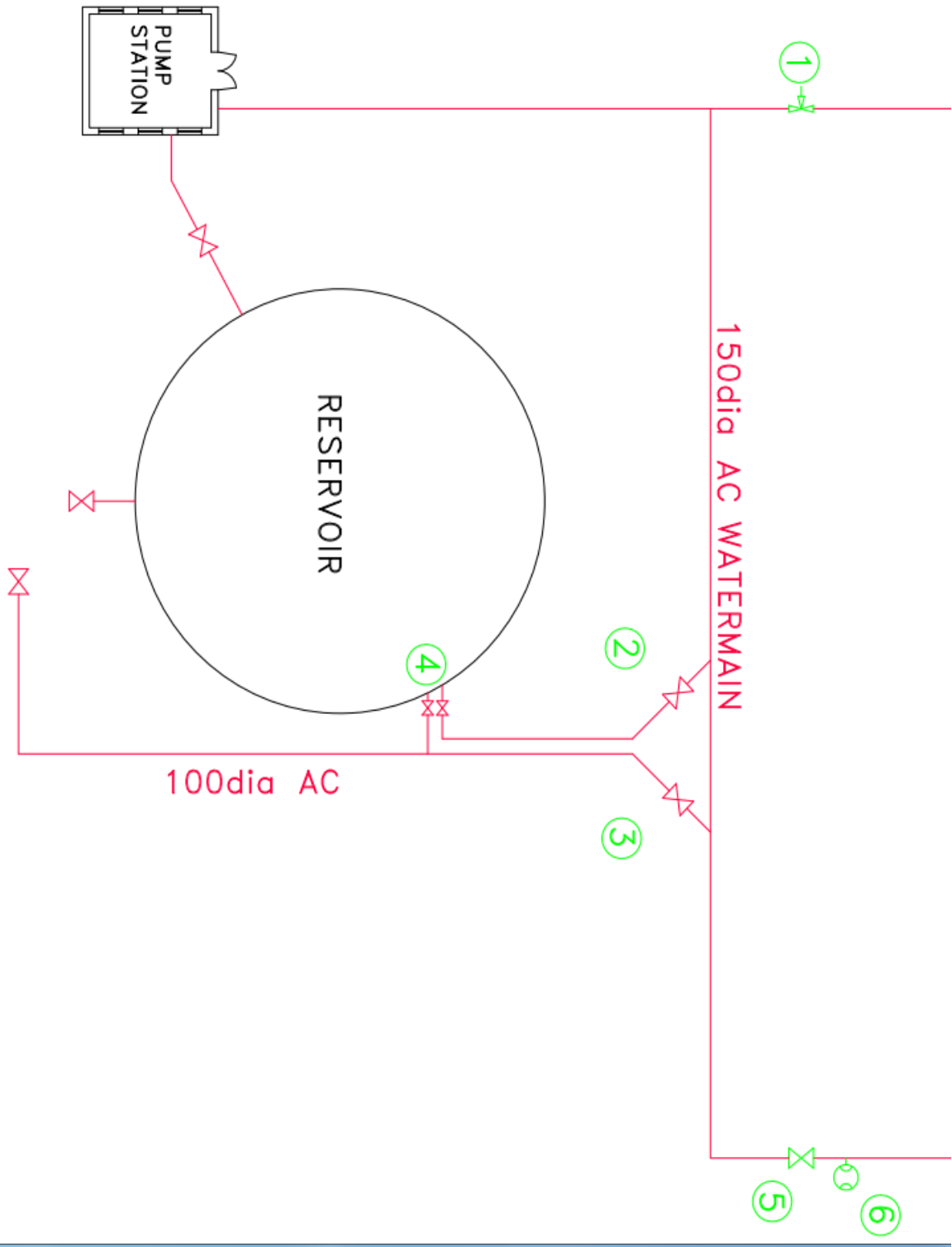
**The refurbishment of Pressure Sustaining valves and shut off valves at Reservoir.**

Upon installation of the new gate valves at points 2 & 3 the 75mm & 50mm Baker angle type pressure sustaining valves at the reservoir must be isolated and removed for complete refurbishment as indicated at point no.4 on the layout.

All internal components to be replaced and the valve must be test for functionality prior to installation.

The external casing must be shot blasted and epoxy coated.

- **N.B** The replacement of the above mentioned valves and works must be completed during the course of a weekend as the incoming water supply must be isolated to iThemba LABS. Please factor this in the price.

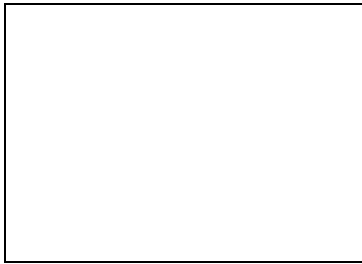
